

OFF-LICENCE

Sections 17 to 19 and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012 (the Act) **B44 WINES LIMITED** (the licensee) is authorised to sell and supply alcohol on the premises situated at **1 Bendemeer Lane, Lake Hayes, Queenstown** and known as **“Wet Jacket Wines”** to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises.

This licence is not endorsed under section 40 of the Act - the licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

- (a) No alcohol is to be sold or delivered on Good Friday, Christmas Day or before 1.00pm on Anzac Day;
- (b) No alcohol is to be sold or delivered on Easter Sunday unless the alcohol is grape wine or fruit or vegetable wine made—
 - i) on the premises; or
 - ii) from grapes or fruit harvested from land on which the premises are situated.
- (c) Alcohol may be sold only on the following days and during the following hours:

Monday to Sunday from 10.00am to 6.00pm

- (d) The licensee must ensure that the provisions of the Act relating to the sale of alcohol to prohibited persons is observed.
- (e) Drinking water is to be freely available to customers, while alcohol is being supplied free as a sample on the premises.
- (f) The whole of the premises is designated as a **supervised** area in accordance with the plans submitted on 10th March 2016 and 18th March 2020.
- (g) According to the Sale and Supply of Alcohol (Fees) Regulations 2013 the premises is assigned the fees category: **Very Low – Cellar Door.**

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force—

- a) Either—
 - i) Until the close of the period for which it was last renewed; or
 - ii) If it has never been renewed, until the close of the period of 12 months after the day it was issued; but
- b) If an application for the renewal of the licence is duly made before the licence would otherwise expire, either—
 - i) Until the close of the period of 3 years after the period for which it was last renewed; or
 - ii) If it has never been renewed, until the close of the period of 4 years after the day it was issued.
